The member will then put his/her balloting form himself/herself at the balloting station or send by post so as to reach the Association before the Friday the 23<sup>rd</sup> February 2018 at 11:00am. The Election Committee will open the ballot boxes in the presence of members present in the Annual General Body Meeting to be held on Saturday the 24<sup>th</sup> February 2018 at 11:00 A.M. in the **Registered Office of the Association** i.e. ST-31, Block-5, Kehkashan, Clifton, Karachi and count the votes in favour of each candidate.

The post for which there is only one candidate, he/she will be considered as elected unopposed; whilst the posts for which there is more than one contestant, then the candidate securing the maximum votes shall be considered as elected for that particular post.

In case of the Joint Secretaries and Executive Committee Members, the contestant securing the maximum votes shall be considered as elected in the sequence according to the number of votes secured by each and according to the number of vacancies.

**6.1.3.11 PROVISION FOR POSTAL BALLOTING**

Where a vote is required under the terms of the Constitution, and serving or the retired/medically grounded pilots who do not expect to be available in Karachi or a station where Regional Vice President is designated, during the electoral process, may apply for the facility of postal ballot on a prescribed Performa. The request will be made before the last date of application published earlier.

This facility of postal ballot will be extended only to genuine cases, such as, serving Pilots who do not expect to be available during balloting period, due to foreign posting, deputation, sickness or any kind of leave etc. and for retired pilots residing in the stations, which are not balloting stations, or due sickness. It will be the prerogative of Election Committee to approve or disapprove the request.
